1. Forest Owner Fees - PEFC Sustainable Forest Management Certification

a. Individual forest owners

Forest area ≤ 50 ha: 5 Euro per property annually

Forest area 51 – 1,000 ha: 0.09 Euro per hectare annually

Forest area 1,001 – 200,000 ha: 0.05 Euro per hectare annually

Forest area > 200,001 ha: 0.015 Euro per hectare annually

b. Forest associations

Forest area ≤ 50 ha: 5 Euro per association annually

Forest area 51 – 1,000 ha: 0.09 Euro per hectare annually

Forest area 1,001 – 200,000 ha: 0.05 Euro per hectare annually

Forest area > 200,001 ha: 0.015 Euro per hectare annually

Payment method:

The accounting period shall be the calendar year;

Annual payment for forest areas > 100 ha;

A 5-year payment for areas ≤ 100 ha;

Payment by bank transfer possible.

VAT will be added to taxes, if applicable

2. Notification fees - PEFC Chain of Custody Certification – single-site and multi-site certificate

Medium 3	25 - 50	2.000
Large	50 - 150	3.000

The biggest	>1.000	6.000

VAT will be added to taxes, if applicable

The annual fee will be calculated for each location separately.

The turnover shall be collected each year during the annual audit and communicated to PEFC Romania if company size has changed.

Discounts are possible for:

Forest service providers participating in the certification of a group.

Companies that are owned by certified forest owners or certified forestry associations and whose main activity is in the forestry sector.

3. Notification fees - PEFC Chain of Custody Certification – Producer Group

Small 1	0 - 0,5	180
Small 2	0,5 - 1	215
Medium 1	1 – 1,5	255
Medium 2	1,5-2	295
Medium 3	2-5	430
Large	5-10	525

The annual fee will be calculated for each participant separately.

The turnover shall be collected each year during the annual audit and communicated to PEFC Romania if company size has changed.
